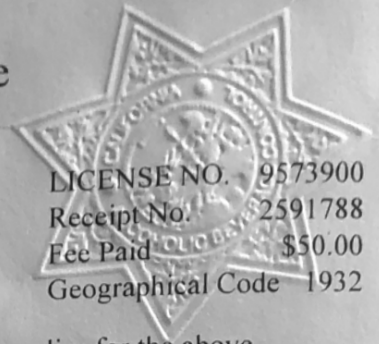

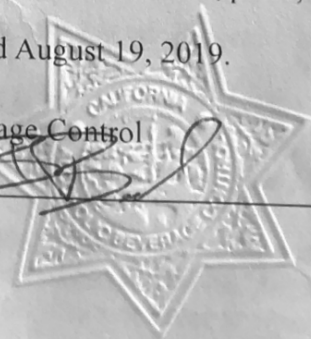

For issuance of a One Day Beer & Wine - License

Under the Alcoholic Beverage Control Act

WHEREAS, petitioner(s) has/have filed an application for the issuance of the above-referred-to license(s) for the above-mentioned premises; and,

WHEREAS, pursuant to Section 23958 of the Business and Professions Code, the Department may deny an application for a license where issuance could tend to create a law enforcement problem; and,

WHEREAS, the issuance of an unrestricted license would warrant the denial of this license;

NOW, THEREFORE, the undersigned petitioner(s) do/does hereby petition for a conditional license as follows, to-wit:

- 10 Sales, service and consumption of beer shall only be permitted in the designated area, as noted on the attached diagram. In addition, no additional dispensing points shall be permitted. Persons may not take beer from the designated area.
- 20 Beer may only be sold in distinctive paper, plastic or Styrofoam cups, and no other cups may be used for the dispensing of alcoholic beverages. These cups cannot be used to dispense non-alcoholic beverages.
- 30 No more than two containers of beer may be purchased by any one person at any one time.
- 40 Non-alcoholic beverages must be available to persons in attendance.
- 50 All persons serving alcoholic beverages cannot consume any alcoholic beverages.
- 60 All persons serving or dispensing alcoholic beverages must be at least 21 years old.
- 70 Sales, service and consumption of beer shall only be permitted in the designated area, as noted on the attached diagram. In addition, no additional dispensing points shall be permitted. Persons may not take beer from the designated area and must be 21 years or older to enter said area.

80 Sales, service or consumption of alcoholic beverages shall be permitted only between the hours of 4pm-8:30pm.


90 The security guard(s) will prevent anyone under 21 years of age from entering any of the beer/wine garden areas.

Petitioner(s) understand(s) that the Department of Alcoholic Beverage Control may, at anytime, revoke this license should the Department, in its judgment, determine that the public welfare and morals were being impaired and/or law enforcement problem was being created.

Petitioner(s) agree(s) to retain a copy of this petition on the premises at all times and will be prepared to produce it immediately upon the request of any peace officer.

The petitioner(s) understand(s) that any violation of the foregoing condition(s) shall be grounds for the suspension or revocation of the license(s).
