- Sales, service or consumption of alcoholic beverages shall be permitted only between the hours of 12pm-5pm on Wednesday 9/11, 9am-7pm on Thursday 9/12, and 9am-7pm on Friday 9/13.
- The security guard(s) will prevent people from carrying alcoholic beverages outside the designated area(s) as noted in the above condition.
- 10 The security guard(s) will prevent anyone under 21 years of age from entering any of the beer/wine garden areas.

Petitioner(s) understand(s) that the Department of Alcoholic Beverage Control may, at anytime, revoke this license should the Department, in its judgment, determine that the public welfare and morals were being impaired and/or law enforcement problem was being created.

Petitioner(s) agree(s) to retain a copy of this petition on the premises at all times and will be prepared to produce it immediately upon the request of any peace officer.

The petitioner(s) understand(s) that any violation of the foregoing condition(s) shall be grounds for the suspension or revocation of the license(s).
