For issuance of an One Day Beer & Wine - License

Under the Alcoholic Beverage Control Act

WHEREAS, petitioner(s) has/have filed an application for the issuance of the above-referred-to license(s) for the above-mentioned premises; and,

WHEREAS, pursuant to Section 23958 of the Business and Professions Code, the Department may deny an application for a license where issuance could tend to create a law enforcement problem; and,

WHEREAS, the issuance of an unrestricted license would warrant the denial of this license;

NOW, THEREFORE, the undersigned petitioner(s) do/does hereby petition for a conditional license as follows, to-wit:

- 1 Sales, service and consumption of alcoholic beverages shall only be permitted in the designated area, as noted on the attached diagram. In addition, no additional dispensing points shall be permitted. Persons may not take alcoholic beverages from the designated area.
- 2 No more than two containers of beer may be purchased by any one person at any one time.
- 3 All persons serving alcoholic beverages cannot consume any alcoholic beverages.
- 4 All persons serving or dispensing alcoholic beverages must be at least 21 years old.
- 5 Tastings shall be served in a 5oz plastic cup with 3oz pours. A line on the cup shall indicate the 3oz pour line.
- 6 Alcoholic beverages shall be sold to only those who have obtained a non-removable wristband identifying the individual as being 21 years of age or older.
- 7 Security staff shall monitor the venue for the consumption of alcohol by underage drinking and for over-serving.

- 8 Beverages of any type may not be transported in or out of the enclosed venue.
- 9 Alcoholic beverages shall be served in clear plastic cups only. No beverages (alcoholic or non-alcoholic) shall be served in bottles of any type.
- 10 Alcohol sales and service shall cease at 5:00 PM or one hour prior to the event end time, whichever comes first.
- 11 The petitioner shall provide 10 VIP entry passes. Said passes shall not be distinguishable in any way to identify the bearer's official capacity.

Petitioner(s) understand(s) that the Department of Alcoholic Beverage Control may, at anytime, revoke this license should the Department, in its judgment, determine that the public welfare and morals were being impaired and/or law enforcement problem was being created.

Petitioner(s) agree(s) to retain a copy of this petition on the premises at all times and will be prepared to produce it immediately upon the request of any peace officer.

The petitioner(s) understand(s) that any violation of the foregoing condition(s) shall be grounds for the suspension or revocation of the license(s).
